4. **Pre-Qualifications:** Refer **Annexure “A”** and fill the same.

5. **Minimum Eligibility Criteria:** To be eligible for evaluation of its tender, the sole bidder shall fulfill the following Minimum Eligibility Criteria as under:

- b) The Bidder should have all necessary licenses, permissions, consents, NOCs, approvals, insurance as required under law for carrying out its business. The Bidder should have currently valid Sales Tax/GST Registration Certificate and PAN No.
- c) **All the bid documents should be duly signed by the Authorized signatory.**

Any Bid failing to meet the above stated Qualification criteria shall be summarily rejected and will not be considered.

- 6) **Rath-Activity Specifications & Cost Component:** The required specifications of IT Rath-Activity are given separately at **Annexure 'D & E'**. Kindly fill in the enclosed annexure and submit the duly signed & stamped quotation on company/agency's letter head.
- 7) **Acceptance of Service Order:** The SO will be awarded to the selected vendor along with all the designs. The vendor must acknowledge the acceptance of the SO by email or on SO hard copy within two days of receipt of SO. Failing to which the order will be considered cancelled and HKCL reserves the right to give the SO to another vendor.
- 8) **Quality:** The Rath Activity must confirm the quality standards prescribed and specifications provided by HKCL. Deviations in the quality standards shall not be accepted under any circumstances.
- 9) **Route Plan:** The Rath-Activity will be conducted in entire State of Haryana covering every Authorized Learning Center in all districts of Haryana. The summary of district-wise locations to be covered is enclosed herewith at **Annexure 'F'** for your reference. The final list of Authorized Learning Centers to be covered will be provided with a final Service Order.
- 10) **Non-Disclosure:** The vendor shall ensure not to disclose any information (whether written or oral) which is of a confidential nature (including content, data software and manuals) obtained or received under the SO. Such information of confidential nature shall not be disclosed by the vendor to any person (other than their employees or professional advisers) without the prior written consent of HKCL. The confidential information shall not be disclosed except (a) any information which has been published other than through a breach of this SO; (b) information lawfully in the possession of the recipient before the disclosure under the SO took place; (c) information obtained from a third party who is free to disclose it; and (d) information which a party is requested to disclosed and, if it did not, could be required by to do so by law.
- 11) **Payment:** Payment shall be made as per the following schedule:
 - a). No Advance payment shall be paid in any case,
 - b). 30% of the Service order will be paid after the 10th day of the activity as part payment.

- c). Another 30% of the Service order will be paid after the 20th day of the activity as part payment.
- d). The remaining 40% shall be paid for final submission of the invoices & work completion report/certificate along with the necessary supporting documents required by HKCL related to work completion.
- e). The amount of TDS and TDS on GST shall be deducted on payments made by HKCL from time to time.
