- 2. **Submission of Quote:** Quotation should reach the given address on or before **10**th **December 2025** between 9.30 AM to 5.30 PM.

- 4. **Material Specifications:** The specifications of the material required are given separately in **Annexure 'A'.** Kindly fill in the enclosed annexure and submit on your letterhead with your signatures and stamp affixed on same.
- **5. Minimum Eligibility Criteria:** To be eligible for evaluation of its tender, the sole bidder shall fulfill the following Minimum Eligibility Criteria.

Note: -

- i) Only those Bidders who meet the Pre-Qualification criteria as specified above will be eligible to respond to this tender. Bidders Pre-Qualification proposal shall contain the relevant information and supporting document to substantiate the eligibility of the bidder vis-a-vis the pre-qualification criteria. The documents submitted shall be verified by HKCL.
- ii) The Bidder should have currently valid Sales tax/GST Registration Certificate and PAN No.
- iii) All the bid documents should be duly signed by the Authorized signatory.

Any Bid failing to meet the above stated Qualification criteria shall be summarily rejected and will not be considered.

- 6. Acceptance of PO: The PO will be awarded to the finalized vendor and a soft copy of marketing material designs will be provided by HKCL. The vendor must acknowledge the receipt of the PO and give acceptance on same via email within two days of its receipt, failing which the order will be considered cancelled and HKCL reserve right to give the PO to another vendor.
- 7. **Finalization of Items:** The item list with quantity provided is tentative (Annexure 'A') and subject to change. The item quantity may increase or decrease based on the requirements of HKCL. In alignment with HKCL norms and management decisions, certain items may be modified at the time of issuing the purchase order to the vendor. The final item list will be confirmed and communicated accordingly to ensure clarity and alignment with organizational needs.
- 8. **Quality:** The quality of printing must match the standards prescribed and specifications provided by HKCL. Deviation from the quality standards may lead to cancellation of the PO.
- 9. **Inspection:** The material to be delivered under this Purchase Order is subject to inspection and approval by HKCL before delivery. HKCL reserves the right to reject the delivery of material if it does not confirm to the prescribed quality standards or is found to be defective, unsafe, unfit or unsuitable in any other manner. Any such deviation may lead to the cancellation of the Purchase Order and non-payment of the consignment sent.
- 10. Delivery: The vendor shall ensure that the material supplied under the purchase order is properly sealed and packed to prevent any damage or deterioration during the transportation/delivery. District-wise delivery locations are attached in Annexure 'D' for your reference and the final delivery addresses and the quantity per location will be provided along with the purchase order or before delivery due date. The transportation cost must be mentioned in your quotation submitted to us. In case of a change in the delivery location the same will be informed in advance and a revised quotation for transportation may be submitted accordingly.

- 11. **Delivery Date:** Material should be delivered to the desired locations within 20 days from the date of acceptance of PO.
- 12. **Non-Disclosure:** The vendor shall ensure not to disclose any information (whether written or oral) which is of a confidential nature (including content, data software and manuals) obtained or received under the PO. Such information of confidential in nature shall not be disclosed by the vendor to any person (other than their employees or professional advisers) without the prior written consent of HKCL. The confidential information shall not be disclosed except (a) any information which has been published other than through a breach of this PO; (b) information lawfully in the possession of the recipient before the disclosure under the PO took place; (c) information obtained from a third party who is free to disclose it; and (d) information which a party is requested to disclosed and, if it did not, could be required by to do so by law.
- 13. **Payment:** Payment shall be made within 30 days from the date of receipt of delivery of product or submission of invoice, whichever is later. Proof of delivery (POD) should be given to HKCL along with the invoice. No advance payment will be made under this PO.
- 14. Quotations should be sent only by post in a sealed envelope at the address provided in point no.

- 15. HKCL reserves the right to place the order with one vendor or multiple vendors considering the rates and quality of samples provided.
